The objectives form part of the full Action Plan, which will be considered by Mon CC 24th October

The Committee recognised the importance of contributing to Mon CC climate emergency action plan and the following points were noted:

Support an action plan as a step in the right direction

- Reducing the impact of vehicle emissions in problematic areas, e.g. Hardwick Hill, suggested this could be addressed through 'no right turn'
- Clarification on how the public will be encouraged to use public transport when bus services have been reduced and train services are at capacity
- Promotion of electric car charger points at homes. How is this being addressed/provided in new developments?

The Town Council were aware that actions should be taken to address climate change and welcomed the opportunity to contribute further to the plan.

The Committee agreed that the points would be forwarded to Mon CC.
